

## AwSUM Product Warranty and Limit/Exclusion of Liability

## THIS WARRANTY AND THE LIABILITY OF AWSUM IS LIMITED AS STATED BELOW.

AwSUM Outcomes Inc. ("AwSUM") warrants that the AwSUM branded lubricant, fuel additives or grease products, or other products, sold by AwSUM or authorized AwSUM distributors conform to AwSUM's written specifications for those products, and comply with the product performance claims applicable to each such product. Most AwSUM products meet or exceed original equipment manufacturers' standards. We guarantee their performance when used in accordance with AwSUM's recommendations, the equipment manufacturers' performance specifications, and under normal operating conditions.

AwSUM will, at its option and subject to the Exclusive Remedy below, repair or replace any damaged parts or equipment resulting from a defect or failure of the AwSUM product if the product is used in accordance with the equipment manufacturer's and AwSUM recommendations.

This warranty is in addition to any and all original equipment manufacturers' warranties and does not invalidate them. Warranty claims to AwSUM must provide satisfactory documentation demonstrating:

- The equipment meets and was operated in accordance with the manufacturer's specification for the equipment, and was used under normal operating conditions, and in accordance with the manufacturer's operating instructions and limitations, including speed, load and temperature.
- The equipment was in good operating condition at the time the AwSUM product was installed, and was maintained in accordance with the manufacturer's recommendations, including compliance with product selection, monitoring and drain intervals.

## The AwSUM Product Warranty does not cover:

- AwSUM branded products used in mechanically defective equipment, where the damage results from, but is not limited to a previously existing condition, abnormal operation, negligence, abuse, damage from casualty, shipment or accident, or equipment modification without written authorization from the original equipment manufacturer.
- Failure of equipment due to non-lubricant issues, including normal wear.
- AwSUM products that have been used in conjunction with any other product or aftermarket additive that has not been authorized for use by AwSUM.

## **Exclusive Remedy:**

AWSUM'S sole liability to Customer and Customer's sole and exclusive remedy for breach of the foregoing Product Warranty is, at AWSUM's option: (a) replacement of such Product upon its return to AWSUM; or (b) credit to Customer of the costs paid by Customer for such Product. Any claim for a breach of a warranty provided herein must be commenced within 60 days from the date the Product was delivered to Customer.

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, AWSUM MAKES NO REPRESENTATIONS, WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, BEYOND THOSE SET FORTH IN THIS WARRANTY. AWSUM DISCLAIMS ANY AND ALL WARRANTIES OR CONDITIONS, EXPRESS, STATUTORY AND IMPLIED, INCLUDING BUT NOT LIMITED TO WARRANTIES OR CONDITIONS OF MERCHANTABILITY, SATISFACTORY QUALITY, AND FITNESS FOR A PARTICULAR PURPOSE. THERE ARE NO WARRANTIES THAT EXTEND BEYOND THE FACE OF THIS DOCUMENT. IN NO EVENT WILL AWSUM OR ITS RESELLERS, DISTRIBUTORS, AND/OR SUPPLIERS BE LIABLE FOR ANY DAMAGES, INCLUDING WITHOUT LIMITATION ANY INDIRECT, CONSEQUENTIAL, SPECIAL, INCIDENTAL, OR PUNITIVE, AGGRAVATED OR EXEMPLARY DAMAGES ARISING OUT OF, BASED ON, OR RESULTING FROM YOUR OR ANY THIRD PARTY'S PURCHASE AND/OR USE OF THE AWSUM PRODUCT, EVEN IF WE OR SUCH OTHER PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
